This is a consumer warning:

Notice is being sent to national and local media NBC Dateline, ABC 20/20 WKMG, WFTV, WKMG, WOFL, WESH, the Orlando Sentinel, and the Associated Press. That this is a situation to be concerned about taking advantage of elderly and the sick.

My name is John (Pj) Pantaleo host of Pj and Friends [www.pjandfriends.com](http://www.pjandfriends.com) I responded to an ad on craigslist. (See attached) I called the number listed 321.445.2544. They answer the phone as PHB – Pacific Health Benefits. I was told this is a company that has been around for over 4 years. (A search of the Florida fictitious name records shows this was reserved in 2008)

I was scheduled an interview on Friday 10/08/10 – at 1pm at 21 Drennen Rd Orlando, FL a check with Orange County Tax Collector shows not listing of a business license with the above named entities for this location. The interview was a group interview there was 5 people in the interview with me. The business was described as follows.

This company claims that they call people who have filled out a survey asking questions about their health, medications, their income. The people that have replied to this survey are put into a ROBO dialer that calls out and asks them to press 1 if they are interested. If they do the call is routed to an agent to sell them on a Health Benefits Card.

The card has a \$99 initial cost with a recurring cost of \$44.95 a month. The funds are collected by ACH check or savings debit. The agent is told that these are Inbound call – (this is a deception) while yes the agent is answering a ringing line it is in reply to a Press 1 Robo-Dialer call.

They do not pay any hourly this is a commission only the agent is paid \$40 per paid sale, they claim they are licensed and bonded however a check has been done and we have been unable to verify this.

The Orange County Tax Collector will be investigating this – a check of the company website [www.pacifichealthbenefits.com](http://www.pacifichealthbenefits.com) at the bottom says the offer is not valid in Florida. A check of the product is that this card has no more value than a card that can be received for FREE from the [United Way](#). This scheme seems to be one to take advantage of the sick and elderly.

Please consider this a CONSUMER WARNING. We have forwarded this information to the FDLE consumer fraud division who will be investigating
